The above conditional continuation in Ex-Post Facto Provisional affiliation is subject to the condition that all the colleges shall make up the deficiencies / conditions mentioned in the Inspection

report the concerned college (**copy enclosed**) within one month from the date of issue of this notification and submit compliance of the same along with supporting documents to the University for further verification. All the colleges are also required to submit the NAAC accreditation certificate at least letter grade 'B', If the same has not yet been submitted with the University being mandatory as per UGC guidelines.

Therefore, you are required to complete the deficiencies / shortcomings / conditions mentioned in the Inspection Report and send compliance for the same with in above stipulated period of one month for necessary verification. On receipt of compliance report, the University will get the compliance verified through an Inspection Committee of the University at the time of considering the extension/continuation for the next academic session i.e. 2019-20. If any college fails to submit the compliance report of shortcoming / deficiencies / conditions within above stipulated period, suitable action will be recommended to the NCTE against such colleges and in that case, the continuation/extension in provisional affiliation for B.Ed./M.Ed. course for the next academic session i.e. 2019-20 shall not be allowed and disciplinary proceeding for withdrawal of provisional affiliation shall be initiated as per Act/Statute/Ordinance of the University.
